Information Sheet: Service Club Donation Checklist

This document provides information for Service Clubs that administer a Community Donations Program. Services Clubs may donate their grant funds to organizations of their choice which meet all Community Gaming Grant organization and program eligibility criteria. Service Clubs are also the only organizations that are permitted to provide one-time donations to an individual or family within their community, in cases where that donation will provide emergency assistance or relieve an exceptional condition or circumstance for the recipient.

Service Clubs must ensure that donation recipients meet all organization and program eligibility criteria outlined in the Community Gaming Grants: Program Guidelines and the Conditions for a Community Gaming Grant. Donations to Individuals or Families

One-time donations are permitted to an individual or family in the community when the donation will provide emergency assistance or relieve an exceptional condition or circumstance. See Section 10.2 of the Community Gaming Grants: Program Guidelines for additional details about one-time donations.

Scholarships and Bursaries

Service Clubs are permitted to provide a scholarship or bursary program, either directly or through an approved conduit organization. A scholarship is provided to a student on the basis of academic merit, while a bursary is provided on the basis of financial need. Scholarships or bursaries may be an eligible disbursement if they meet the following criteria:
